**REBATE APPLICATION**

Please be aware of these eligibility requirements:

1. A copy of the 86-Point Vehicle Inspection Report and paid invoice provided by the Approved Auto Repair facility are required to process the VIP rebate application.
2. The paid receipt AND 86-Point Vehicle Inspection Report must be made out to a valid AAA Premier member.
3. The request must be postmarked or received within 60 days after the date of the 86-Point Vehicle Inspection.
4. Limited to one VIP rebate per AAA Premier cardholder, per membership year.
5. Maximum rebate amount is \$45.00.
